



## Wooden Boat Festival Virtual Event Tickets Giveaway OFFICIAL RULES.

**NO PURCHASE NECESSARY TO ENTER OR WIN PRIZE. THIS CONTEST IS OPEN TO FIRST FEDERAL CUSTOMERS AND NON-CUSTOMERS.**

1. **Eligibility:** This Sweepstakes is only offered in the state of Washington and entrants must be legal residents of the U.S., 18 years old as of the first date of each applicable Promotional Period as defined below. Employees, officers and directors of First Federal ("Sponsor"), its subsidiaries, affiliates, distributors, advertising and promotion agencies and their immediate family members (defined as spouses, children, parents, siblings, in-laws) and those living in their households are not eligible.   - b. Follow @ourfirstfed on Instagram AND commenting on the giveaway post.A MAXIMUM OF TWO ENTRIES PER PERSON IS ALLOWED: one as described in a. (Facebook) and one as described in b. (Instagram).
